## **Vendor Information and Guidelines**

### **2011 Booth Fees until August 15:**

- Regular booth and food booth fees are \$50 without electricity or \$55 with electricity for a 12' by 12' space.
- Booth fees are payable in advance with registration form
- Non-profit organizations that wish to sell non-food items will be charged \$25 for a booth.

### **After August 15, booth fees will increase to \$65.**

- Please rent as many 12' by 12' spaces as you will use. Indicate on the registration form if you are using a tent. Fees must be submitted along with the registration form via check, money order or PayPal.
- **Arts and crafts vendors are encouraged to sell original crafts only and have hand crafted items. Other merchandise must be approved by the Tumbling Waters Vendor Committee. Pictures of items should be submitted with the application if you are a new vendor.**
- Franchised and chain food establishments are not allowed to participate.
- Booths for educational exhibits and demonstrations are free if no food or merchandise is offered for sale. A registration form must be submitted and approved (See Attached).
- Participants are responsible for any equipment needed such as tables, extension cords, tents, etc.
- Operating hours are Saturday, 10 a.m. to 6 p.m. and Sunday, 12:30 to 5:30 p.m. **The festival will be held rain or shine.**
- **Set up time is Friday, September 16 from 12:00 noon until 7:00 p.m. and Saturday 8 a.m. until 9:30 a.m.** Sign in at the registration table near the covered bridge to get booth and parking locations. A map to the park is on the back of this page and on the web site.
- The park will be secured at night with night guards on duty. Booths will be secure Friday and Saturday nights.
- **No pets, camping, or overnight stays are allowed in the park.** Jackson County Park and Recreation Department Regulation.
- Tumbling Waters Board may limit the number of food and craft vendors. Food booths will be limited and duplication of food products will be controlled.
- The festival is a two-day event. Please plan to participate both days.
- To register until August 30, complete the attached registration form and mail to **Tumbling Waters Society- Vendor, P. O. Box 164, Jefferson, GA 30549. To register after August 30, please call (706) 367-8688 or (706) 367-8736.** Leave a message if no one answers. Please speak slowly and distinctly and making sure all numbers can be understood and please speak the return phone number at least twice.
- You will be notified when your application is received.
